- **Aadhaar card** or any valid government-issued ID.

- The scholarship application window typically opens at the start of the academic year, and the deadlines for application submission vary each year. Students are encouraged to check the **Tata Capital website** or **scholarship portals** like Buddy4Study for specific dates.
