## **Top Class Education Scheme for SCST Students**

#### Introduction to the Scheme

The Top Class Education Scheme is a centrally sponsored scheme by the Ministry of Social Justice and Empowerment (for SC students) and Ministry of Tribal Affairs (for ST students). It aims to promote quality education among meritorious SC/ST students by providing full financial support for pursuing studies in premier institutions in India.

#### **Objectives:**

- To provide financial assistance to meritorious **SC/ST** students.
- To cover the entire education cost in top-rated institutions.
- To promote social inclusion and equity in education.

#### **Implementing Bodies:**

- Ministry of Social Justice and Empowerment (SC)
- Ministry of Tribal Affairs (ST)
- Operates via the National Scholarship Portal (NSP).

### **Eligibility Criteria**

### **General Requirements:**

- Must belong to Scheduled Caste (SC) or Scheduled Tribe (ST).
- Must have secured admission in a notified institution listed under the scheme.

#### **Income Criteria:**

Family income should not exceed:

- ₹8 lakh per annum for SC students
- ₹2.5 lakh per annum for ST students (may be revised as per notifications)

## **Institution Type:**

Student must be enrolled in top institutions such as:

- JITS, IIMS, NITS, IIITS
- AIIMS, NLUs, IISERs
- Central/State Government-funded institutions
- Private institutions listed under the scheme

- 8. Wait for verification from the institution and authorities.
